## **Podiatry-Skin Substitute Billing Guidelines**

### Qualifiers for skin graft:

- The wound has not responded to treatment for four weeks.
- The wound size has not reduced by more than 50% by using standard wound care protocol.

#### Disqualifiers for skin graft:

- The wound has shown signs of responding to treatment.
- A skin graft has been applied, to the same area, by another or the same doctor within the past six weeks.

**Pre-authorization instructions**: Medicare does not need pre-auth. However, for CPT Q4161 get pre-auth from commercial insurances. Taking pre-auth online from the respective insurance website is best option. Insurance request for prior documentation to check qualifiers are properly documented and then determine medical necessity.
